

The Home Resources for Learning Scale

The Home Resources for Learning (HRL) scale was created based on students' responses to questions in the Student Questionnaire concerning availability of home resources (number of books, and number of home study supports) and their parents' responses to questions in the *Learning to Read Survey* (number of children's books, level of educational, and occupation), as described below.
